# 523.1 Report from Paul Paddock

A report had been sent through together with photographs. The orange water which was reported is flowing clear and the sediment appears to be bright orange, there doesn't appear to be any sort of pollution. There is a bridge in the Gorse needs to be looked at due to the size of the gap caused by the ground eroding. Assistant clerk is to ask the handymen to have a look at it. The paths are in reasonable order and the bluebell walk went very well.

## 523.2 Update on works

The work at the viewpoint has been done together with the area around Peters Patch and also a limb has been cut from a tree at Peters Patch. Cllr Harwood was in the Gorse when the contractor was there and had spoken to him, Cllr Harwood was impressed with the contractor and commended him on his work.

# 524.1 Report from Katie Smith

A report had been prepared which was handed out. There appears to be an increase of litter within the woods and it needs a thorough litter pick. In respect of the pipe in the woods the homeowner needs to be contacted about it. This will be discussed later in the meeting. The Easter Egg hunt was a success and Katie, the Wood Warden said it had been a privilege to be involved in it. At the request of the Assistant Clerk some trees which were behind 30 Wood Lane had been looked at. There appears to be 2-3 dead trees. The Assistant Clerk confirmed that she had contacted Ian Kennedy, our consultant who will hopefully be able to go and have a look at those trees. It was agreed to wait to see what Ian Kennedy advises to do with these trees.

# 524.2 Update on works

The areas which needed coppicing have been done, the large limb has been taken off the beech tree. Another tree which was hung up near to the stone entrance has also been taken down. The glade work is still to be done.

## 524.3 To discuss the water pipe in Wickersley wood

The water is still flowing into the woods. Assistant Clerk had contacted the Water company and also the Environment Agency who cannot assist. It is now considered that the homeowner needs to be contacted about this issue.

## 525.1 Debrief of Easter Event
