

## Wickersley Parish Council - Regulation 121B Monitoring Report

### Financial Year – 2022/2023 (1<sup>st</sup> April 2022 to 31<sup>st</sup> March 2023)

A Local Council must use CIL receipts passed to it to support the development of the local council's area, by funding—

- (a) the provision, improvement, replacement, operation or maintenance of infrastructure; or
- (b) anything else that is concerned with addressing the demands that development places on an area.

The Local Council will be required to publish the following report on its website and on the website of the Borough Council. The report should be published no later than 31<sup>st</sup> December following the reported year.
